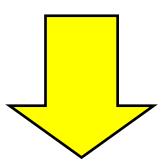

CAM	Government negotiates loan from Exim Bank India which consists of the introduction of 1,000 tractors and assorted tools for the production of maize and rice
BEN	Subsidy rate on procurement price by the farmers (50%)
MAD	Subsidy, credit payment
MAL	Agricultural input
MOZ	Small irrigation material subsidies: 65%, Animal machineries subsidies: 80%

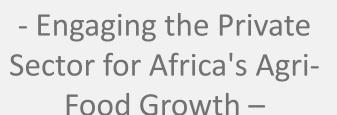

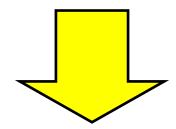
