### **Opening**

### Agenda 1: Chairmanship and minutes of the previous meeting

- Minutes: This meeting will look through the minutes of the GM3, rather than the SC meeting for practical reasons.
- Only the Executive Summary is perused as the reconfirmation of salient points agreed. Particular emphasis should be put on "4. Next Steps (page ii and onwards)" as the basis of this meeting.

### Agenda 2: Progress of the CARD Initiative

  - Progress of the G1 countries. This could dominate the discussion with various focus, including:

  - Progress of the G2 countries. Some points of discussions would be:
    - Improvement in the process, reflecting the lessons learnt in the G1 process.
    - Actions for less advanced countries, including the strengthened process assistance by PAOs
  - Alignment with CAADP. Discussion shall be facilitated towards:
    - Common perception on the way in which the NRDS implementation contributes to the CAADP implementation at the country level (i.e. elaborating CAADP programs to bankable actions on the ground)
    - Actions to further strengthen the linkages between the CARD Initiative and the CAADP process both at in-country level and at the

regional level (i.e. institutional linkages between the CARD Secretariat and the NPCA Secretariat)

  - Any suggestions on meeting that CARD should attend in order to expand the network for better chances of increased funding opportunities or other purposes?
