


#### **CAADP IN TANZANIA**

#### **CHRONOLOGIES**


- In 2009, the CAADP Donor Platform was held in Ethiopia agreed to conduct an assessment in the AU Countries to assess the complementarity of NEPAD-CAADP principles and pillars in their on-going frameworks.
- In March 2010, this assessment was conducted in Tanzania followed by stock taking towards Roundtable discussions and Compact signing (Brochures and Briefs detailing gaps and proposed interventions prepared and are available)

- The On 06th July 2010, Roundtable discussions involving all stakeholders – under the chairmanship of the Prime Minister of the United Republic of Hon. Pinda
- on 8th July 2010. The country CAADP -Compact signing was witnessed by H.E.Dr. Jakaya Mrisho Kikwete, the President of the United States of Tanzania



- Technical Review was held from 27th -31st May 2011
- The Technical Review findings were presented in a stakeholders workshop on 30th May 2011 and agreed Country Report produced in July 2011

### **Outline of the Investment Plan**

- TAFSIP is a ten-year investment plan which maps the investments needed to achieve the CAADP target of 6% annual growth in agricultural sector GDP.
- As a sector wide framework, the URT envisage this target through allocating a minimum 10% of its budget to the agricultural sector, with support of the international community, the private sector and civil society



### Implementation of TAFSIP:

Through Programme Technical Working Groups (P-TWGs), TAFSIP Secretariat and the CAADP Country Team.

• TWGs formed around the seven strategic areas of the TAFSIP drawing members from the key institutions implementing the respective thematic programme areas.

- Engaging all Public, Private, Non State Actors, Civil Societies, Farmers and Development Partners
- Government to allocate at least 10 % of its budget.
- Private sector and other players to join efforts to bridge gaps.



# **Current Status**

- TAFSIP GAFSIP proposal secured USD 22.9 million and Preparation of the Project Appraisal Document is in progress
- The 10% budget allocation: By year 2010/11 we were at 7.9%, in year 2011/12 at 6.9 % and current year 2012/13 slighly dropped to 5.3%.
- Agric growth rate: 4% (which is below the national average economic growth of 7% and CAADP target of 6% annually.
- Agric GDP contribution: Currently at 23.7
