

September 2011	An Agricultural Transformation Agenda was developed by the Federal Ministry of Agriculture to be presented to the President. Rice is one of the key crops selected with the aim of achieving self-sufficiency in its production and processing and discouraging importation.
September 2011	Rice Value Chain Transformation Stakeholders Forum organised by the Federal Ministry of Agriculture and Rural Development in line with the Agricultural Transformation Agenda
2011	Increased processing capacity of 125,000t p.a. by the coming online of 2 independent medium rice processing mills. Sarauniya Rice Mill, Kano - 80,000t p.a.; 2000 Out-growers; Gouria Rice Mill, Azare, Bauchi State – 45,000 t p.a.; 2500 Out-growers
2011 Q4	2 Rice Processing Mills under the FGN Special Rice Processing Intervention Programme will be commissioned before the end of the year, and the 3 rd before the second quarter of 2012 increasing the country's processing capacity by another 150,000t p.a. A private sector rice mill of 150,000t p.a. will also be ready for operations by the end of the year
2011-2012	Provision has been made for the production of 14,600t of certified seeds of high yielding varieties for the 2012 cropping season (mainly Faro 44 and 52) 3 NERICA (1no. upland and 2 nos. lowland) varieties are expected to be released in time for the 2012 cropping season
2012	Rehabilitation of 5 irrigation schemes covering a total of 8,678 ha in 5 States of the Federation under the Agricultural Transformation Agenda
April 2012	8 medium-scale rice processing mills under the Agro-Industrial Estate Project of the Federal Government with a total capacity of 49,000 t p.a. Expected delivery date is April 2012. Mills will be concessioned to private sector operations.

Issues

- Regarding implementation of the Working Weeks
 - Approval recently given for the implementation of the working week.
 - Expansion of working week to accommodate enlarged rice stakeholders under the Agricultural Transformation Agenda.
- Regarding negotiating the champions
 - Full support of all members of the champion Group and Mr. President of Nigeria is guaranteed.
- Regarding securing the funds on rice-related interventions
 - Funds available, though limited, from Federal and State Governments to support rice production, processing and marketing.
 - JICA currently supporting the establishment of two pilot projects on Rice Post-harvest Processing and Marketing Centres in Nassarawa and Niger States.
 - KOICA also supporting the establishment of a Rice Processing Complex (RPC) in Niger State.
- Private Sector Situational Disabilities
 - Prohibitive interest on commercial loans
 - Stringent conditions for accessing the various intervention funds set aside by government for agriculture in the case
 of small scale farmers
 - Fear of policy changes discouraging private investors from major investment in large scale rice processing mills and related infrastructure particularly in the aspect of rice waiver and tariffs on importation
 - Infrastructural challenges (road, power and water supply)
