- Rice Stakeholder's workshop (Attended by over 80 stakeholders including Private Sector and DP's (FAO, JICA, WFP, EC, SG2000, Brac) on 12th July 2011 at Hotel Africana
- On World Food Day of 16th Oct. 2011 at Abi-ZARDI Arua District,

Issues/Challenges faced in Developing the Implementation Framework

- Working Sessions
 - Stakeholder involvement is still weak.
- Negotiating with Champions
 - This Financial year rice is not the priority crop for Government support (DSIP) however the Government has still continued to provide funds for the old projects and is seeking a loan for rice irrigation and seed project from IDB.
- Securing funds
 - Some interventions such as construction of irrigation infrastructure are very expensive thus its challenging to find funding support for them.


