## 1. Preliminary phase

- Invitation letter from CARD to participate in the process in February 2015
- ▶ Letter of acceptance from the Permanent Secretary of the Ministry (SGM) in February 2015
- Appointment of rice task force members (TF) by notice from the SGM in April 2015:
- 11 members: Planning Directorate (2), Agricultural Research (1), Agricultural Engineering (1), National Crop Production Directorate (1), Departmental Directorate for Agriculture (1), Farmer Organization (3), National Company for agricultural promotion (1), Resource person (1).
- TF preparatory session to discuss the launching of the rice seed initiative in April
- Launching of the initiative by video conference in April 2015
- Development of TOR to seek support for structures intervening in the rice for the financing of the initiative

## 2. Working tools for the Rice Seed Sector Improvement initiative in CARD countries

Data collection

- TF working session: Allocation of data collection tasks to research, the seed certification directorate and the seed production directorate (Crop Production Directorate)
- First summary by a two-member team
- Collection of supplementary data by the same entities
- Finalization of the document "Working tool for the Initiative for the Improved Rice Seed Sector in CARD countries" which was sent to CARD for preparation of the first working week
- Invitation to the first working week: TF and resource persons (Department of seed certification, National Agricultural Development Fund) in July

## 3. First working week on the NRSS

- From 3<sup>rd</sup> to 7<sup>th</sup> August 2015 with the support from the CARD secretariat: one consultant, and Coordinators
- 17 Participants
- Main outcomes
- Better knowledge of the rice seed sub-sector
- Ownership of the rice seed industry development process with the aim of increasing rice production by the various players in the sub-sector
- Identified the main constraints to the development of the rice seed industry and the corresponding suitable solutions were identified
- Inputs into the first draft of the NRSS were collected

## 4. Inputs for drafting the NRSS

#### 4.1. Vision:

"An organized, efficient, secure and sustainable rice seed industry that permanently meets the productivity needs and overcomes competitiveness challenges by 2025"

#### 4.2. Overall goal:

Ensure the availability of and accessibility to seeds with sufficient quantity and quality in order to meet the needs of rice farmers.

#### 4.3 Specific objectives:

- Stable and timely supply of improved rice seeds in sufficient quantities and qualities to at least 50% of rice farmers by 2025 at an affordable price;
- Diffuse a wide range of improved rice seed varieties to meet the needs of rice growing zones and increase the utilization rate of certified seeds to 50%;
- Create an enabling environment for private investment in the rice seed industry and facilitate the trade of rice seeds;
- Strengthen the institutional and legal framework (legislative and regulatory framework) governing the rice seed sub-sector

## 4. Inputs for drafting the NRSS (cont'd)

#### 4.4. Strategic areas

- Rigorous enforcement of the regulations and standards relating to rice production and to the structures involved in the rice seed sub-sector
- Organized and standardized production, meeting the needs of farmers
- Gradual withdrawal of the State from the supply and distribution for supporting private entrepreneurs
- Ayailability of the supply in rice growing areas

#### 4,5. Strategic Principles

- Compliance with the legal and institutional framework of the seed subsector
- Consideration of the improved seeds for the coordination of the sector and the planning of the production
- Gradual transfer of production, collection and distribution of basic and certified seeds to the private sector
- Decentralized distribution of the basic and certified seeds

## 4. Inputs for drafting the NRSS (cont'd)

#### 4.6. Examples of issues and solutions

Poor application of policies	Operationalize the National Seed Committee with allocation of sufficient funding Rigorous compliance by each actor (private and public) with assigned roles
Limited technical and financial resources for entities tasked to implement laws and regulations	Implement PNS by each decree  Make necessary means available to

#### Production, Control and Inspection

Low uptake of improved seeds and unsuitability of adopted varieties in different agro-ecological zones	Increase awareness and inform farmers of the importance and benefits of adopting improved seeds
Difficult access to specific inputs	Establish business relationship between input distributors and growers, Support establishing input credit schemes

## 4. Elements for drafting the NRSS (cont'd)

#### 4.7. Interventions/Actions and priority areas

- Legislative, Political, Institutional Aspect
- Lobbying to speed up enactment of decree on Attribution, Organization, Functioning and Establishment of the CNSV
- Proposing amendment of laws and regulations enabling the promotion of agribusiness in the rice seed sub-sector
- Provide information to and awareness-raising of actors on rules, regulations and standards in this field
- Strengthening technical, material and financial capacity of the Official Seed Control and Certification Unit.

## 4. Elements for drafting the NRSS (cont'd)

#### 4.7. Interventions/Actions and priority areas (Continued)

#### Seed Production Aspect

- Develop and secure irrigated areas at research stations and promote private small-scale irrigation for the benefit of seed growers
- Planning of recruitment of research staff and build their capacity to ensure continuity in rice production: breeders, research assistants, technicians
- Strengthen control and certification with compliance regarding variety standards: provide means and motivations.
- Build capacity of seed producers: training, provision of equipment, and support to produce quality seeds,...
- Establish a unit for seed processing and treatment accessible by research stations
