# Angola's rice sector - Background

### Significance of rice sector development

Role of rice in food security, poverty reduction (and/or exportation/trade) Rice plays a very important role in food security and political stability of Amgola. Is the second cereal more consumed after maize. The national consumption amount is more than 450,000 Ton per year; The importation volume is more than 400,000 Ton per year and the national production is about 10,000 Ton per year. The increase of national rice production, will strengthen the food and nutrition security and reduce greatly the use of foreign currency for its importation, further will activate & promote employment and income of rice producers, that's why this crop is given a strategical priority by the government of Angola in the agricultural sector.

### Major challenges and opportunities



. To increase the rice production three times as many as now in five years, through expansion of the area and increasing the yield.

### **Targets**

### Strategic/Specific objectives

- ..Expansion of area: Expand the area by 20,000 ha
- ..Productivity enhancement: To achieve the yield of 2,5 Ton per ha
- ..Quality improvement: To introduce rice milling machines (de-huskers) in a sustainable way
- ..Capacity building: Training of extension workers and researchers
