Eighteenth Steering Committee Meeting (SC18) of Coalition for African Rice Development 29-30 September 2022 at Dar es Salaam

CONCEPT NOTE

We launched the second phase of CARD at TICAD7 in 2019. This year we just had another CARD side event along the sideline of TICAD8. The side event was attended by H.E. President of Madagascar, President of African Development Bank, President of AGRA, President of JICA, Assistant Director General of FAO, among others. Over 350 people joined the event. The speakers discussed the impacts of current global affairs on rice markets in Africa and measures that could help African countries mitigate the adversaries. Improving the quality of locally produced rice was emphasized as one of the important measures for protecting the continent from any potential rice price crisis in international market.

Since the 8th General Meeting (GM8) last year, there has been a steady progress in formulation of 2nd National Rice Development Strategy (NRDS II) in CARD member countries and Regional Rice Development Strategy (RRDS) in ECOWAS and EAC. These efforts could help improve CARD member countries effectively utilize existing opportunities and minimize risks faced by the rice sector. At the GM8, we endorsed a new M&E framework for CARD, based on R.I.C.E approach that accounts for resilience (R), industrialization (I), competitiveness (C), and empowerment (E). This M&E framework allows tracking of the progress in rice sector development at national, regional, and continental levels. Another highlight of the GM8 was that AATF officially became a new member of the CARD Steering Committee.

FAO statistics reveal that average global rice price index has increased in July 2022 by 7.2% over its value in 2021. Total paddy production in Sub Saharan Africa stood at 33 mn MT in 2020, a 2.5 % increment over 2019. To achieve the CARD's target of 56 mn MT by 2030 however, the growth in production needs a much faster pace than the current level. Given global headwinds such as rising input costs and supply chain snags, additional acceleration measures need to be discussed more intensively by CARD SC members at SC18.

CARD made big strides in terms of number of member countries which completed their NRDS formulation process in 2021/22. Based on the decision over the M&E framework at GM8, CARD Secretariat has started working with those member countries that had already prepared their NRDS2 on conducting surveys for setting baseline figures for the CARD's 12 common indicators. So far, 10 countries (Kenya, Tanzania, Rwanda, Malawi, Ghana, Nigeria, Burkina Faso, Côte d'Ivoire, Togo, and Mozambique) have completed or started or are about to start the baseline survey.

Since the start of the CARD phase 2, we have been working closely with RECs on devising RRDS. ECOWAS has already prepared its action plan under ECOWAS regional rice strategy (Rice Offensive). EAC is in the final stages of validating EAC Rice Development Strategy (ERDS). Our support at the regional level is based on the principles of mutualism and complementarity to NRDS implementation in the respective Partner States. In this regard, SC members need to discuss on how to lead the implementation processes and extend the strategy formulation processes by the remaining RECs, viz., COMESA, ECCAS and SADC.

In order to continuously provide more effective support to the M&E process in member countries on implementation of both the national and regional strategies, CARD Secretariat is now establishing a new interface for CARD's M&E tools through our website for: - 1) tracking overall indicators (production, area harvested, yield, self-sufficiency) and RICE indicators, 2) showing locations and details of rice related projects in each member country and by each supporting partner, and 3) presenting geographical areas of interventions (heat map) in each country. With this information, stakeholders including the SC members can effectively reckon specific support required for rice sector development in each country.

Going forward, we need to expedite our support to the remaining CARD member countries on formulation and/or finalization of NRDS2, and setting M&E baselines. To complement our efforts on M&E, we are planning to support all CARD member countries in organizing 'Annual Rice Sector Review'. In this context, support from the SC members' local offices is keenly sought and welcomed. How best we can support organizing such a review meeting will hence be one of the agendas for discussion at the SC meeting.

Expected Outputs and Program

The 18th CARD Steering Committee meeting (SC18) will be held during 29-30 September, 2022 in Dar es Salaam. Objectives of the SC18 are to (i) share and discuss the progress made in the last one year, and (ii) review and endorse the planned activities for 2022/23, with special attention on CARD's M&E framework.

The expected outputs of the meeting are as follows:

- > Information shared over progress made on: -
 - 1) NRDS formulation and implementation,
 - 2) Regional rice strategy formulation and implementation,
 - 3) Activities of SC members on rice sector development in CARD member countries
- M&E system on rice sector development at both national and continental levels explained and understood
- ➤ Highlights from CARD side event at TICAD8 reported
- > Annual plan for 2022/23 discussed and agreed

More details on the venue will be communicated as soon as it is decided. The meeting will be co-chaired by EAC Secretariat and AATF, as per our usual practice of rotation. The tentative program is shown below.
